President's report: (Andrew Lockley)

- Actions from previous minutes – Nil
- 4WD Spectacular – roundup pending noting the gate was approx. 40% under. Exhibitors – 180 sites sold but only 140 turned up. This will result in a reduced return for the club and identified charities.
- The reduced funding will need to be factored into the club budget.
- Show feedback to the President in writing prior to 9th May 2020.

- Need to discuss new members and trips.
- ~\$18k in the bank.
- Heritage drive account is growing – approx. ½ way to the expected break-even point.
- Tax dept has advised we can stop paying provisional tax.

I am not expecting any further bills associated with the 4WD Spectacular.

Note that the large sum in the Heritage account reflects advance payments for this year's Heritage Drive.

I can only reinforce that what money we have in the bank is it. I do not anticipate any monies coming in until right on the end of the FY, when subs become due, and any surplus from the 4WD Spectacular comes our way. Sizable payments which will be due before the end of the FY are: trailer rego and insurance (\$900), plus 4WD Assn membership and insurance (\$2000).

I anticipate that, due to the hot weekend and low numbers of exhibitors and visitors, Spectacular income may well be down. One thing that will need considering and approving by members by April at the latest is subs for next year, especially if it is apparent by then that the Spectacular income will be reduced.

Hi all,

It has been a busy couple of weeks, but also very positive.

First off I would like to thank everyone for their support at the AGM, not just for me as President but for the whole committee. We welcome Brian Bird to the committee and I am sure he will be another positive for the Association. The Quarterly and AGM went smoothly and with the changes to the constitution it was productive as well. Everyone enjoyed themselves and had a laugh while doing it, which is great as we are all volunteers.

The fires are rightly the prominent issue at the moment and it is affecting everybody, but some more than others. We have a lot of members that have been directly affected by them and also their communities. We are working with them in ways to support both our members and the affected communities. We will be organising things for next Easter for clubs to be able to help these communities so please keep Easter free so we can support our members in their support for their areas.

I had a National Parks Advisory Council meeting through the week and we were given a brief on the fires, firstly I would like to say I have never seen these guys worried like this before, to say the fires are unprecedented is an understatement. I see a lot of people saying we have had bigger fires, yes, but these are not over yet and by Christmas these will be the biggest. Also we always have fires, yes, but not in our rain forests. The Gondwana Rainforests have no history of fire and we are losing them to wildfire right now. As for the effectiveness of hazard reduction with these fires it will need to be carefully looked at, we certainly need to keep it up but most of these fires are canopy fires started by lightning that are not touching the ground cover. The lack of moisture in the air means it does not matter which way the wind comes from it just feeds the fire and because of the low moisture we have more lightning strikes it's a vicious circle.

Also please understand that the rangers are all trained to help in fighting fires. Parks don't like to promote this as they are paid workers unlike the volunteers but I believe we need to, especially when you hear what they are doing, they deserve all the accolades that are being given to the rest of the people involved. This means though that park staff are stretched and will mean parks will be closed if there is any threat, please observe all warnings and stay safe.

I would like to finish up by wishing everybody a happy and safe Christmas, whether it

be with family or sitting by a river, just have fun and see you all next year.

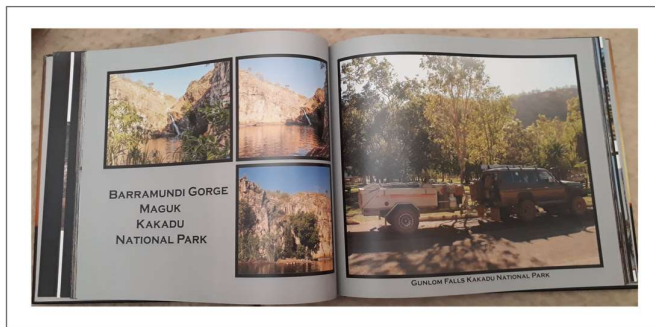

Bull bars

Is your bull bar legal?

Bull bars used in NSW must comply with the [Technical Specification: Requirements for vehicle frontal protection systems fitted to light vehicles \(PDF, 2.1Mb\)](#)

Reference to this Technical Specification is now included in Schedule Two of the Road Transport (Vehicle Registration) Regulation 2017 creating a clear and ongoing regulatory framework for the safe use of bull bars in NSW.

Clear requirements for safe bull bar use in NSW

From 16 September, the Technical Specification (previously referred to as Bull Bar Tolerances and Conditions) will continue to provide clear and consistent guidance to motorists and industry stakeholders to help ensure that any bull bar that they purchase, sell, install or manufacture for sale is permitted under NSW regulations.

The Technical Specification will also ensure vehicles meet other applicable standards affected by the bull bar, such as ground clearance, width, obscured lights and number plates, and the driver's view of the road.

There are no major changes

This Technical Specification replaces, on an ongoing basis, previous requirements that have been in place since 2014 under a series of Ministerial Exemption Orders. It will be 'business as usual' as making the Technical Specification permanent does not result in material changes for motorists and industry stakeholders.

Please note a bull bar is a type of Vehicle Frontal Protection System (VFPS). VFPS is the term used in the Regulation to encompass bull bars, nudge bars and similar devices fitted to the front of a vehicle.

Mitsubishi Motors Pajero Club Challenge 2020

February 8th and 9th

This annual event is organised by the Pajero 4WD Club of Victoria and has become one of the best and most challenging self guided, off road Navigational events in Australia. The Pajero Club Challenge is open to experienced Four Wheel Drivers and experienced Navigators. All brands of 4WDs are welcome, but vehicles must be set up with good off road tyres and suspension lift to suit High Country terrain.

The Mitsubishi Motors Pajero Club Challenge is a **24-hour** 4WD navigation competition, split into four sections, each of which allows for 3-4 hours of driving. The driver and navigator(s) find their way from point to point, answering questions as they go. Many teams have multiple navigators and also swap drivers; it's a team event!

Checkpoints are manned by members from various 4WD clubs. There are special stages where points can be gained, such as a written navigational test, skills task and team activities. Compulsory rest stops at each stage. Includes Saturday night meal and Sunday morning breakfast.

The focus of the event is teamwork, observation and navigation. The terrain will be typical of High Country driving and teams must prepare for dry and wet conditions. This is not a race because the objective is to make the least number of errors to beat the test of the competition.
