President's Report (Andrew Lockley)

President apologised for not achieving commitment to clean up and publish meeting minutes as promised and will address with committee at next meeting.

Updated members on 4WD Show termination, Letters sent to other clubs, LRC has been remitted approx. \$8600 as our equity from the show retained funds. LRC has offered to continue to engage with other clubs in "good faith" to determine disposal/carve up of remaining assets. Will await their contact.

President working with Eastlakes with a view to resuming normal meeting schedules from September and will advise membership asap. Currently targeting 7th Sept for next Ordinary Meeting with first Committee Meeting booked in for Monday 17th August.

President reminded group the AGM is planned for 12th October with opportunity to nominate for committee roles

Treasurer's Report: (David Wade)

Treasurer present report as per published email (reproduced below).

LRC cheque account \$3028.65

LRC reserve account \$33068.66

PayPal \$1091.25

Heritage Drive account \$7580.49

First off, I'll start with expenditure from 1 July to date, and that's pretty simple:

two monthly payments for our MYOB licence, each of \$33.60; and

two payments, each of \$50, to the Bungendore Showground Trust for use of the facilities for the July and August meetings.

Income is equally simple:

quite a number of subs receipts through July, now tapering off;

one member used the Club trailer; and

the sum of \$8670 from the 4WD Spectacular, our share of the Spectacular's bank balance with the LRC's withdrawing from the Spectacular.

Note – these Spectacular funds will most likely be treated as income by the Tax Office, so will be taxable (30%).

Funds from the Spectacular were not taken into account in my budget for the year, which I stressed would be tight. That pressure has now been relieved; first through the small and unexpected Spectacular surplus in June, and now the return of our share of the Spectacular's bank balance on our withdrawal. However, as there won't be any future Spectacular income, we will still need to manage carefully.

In the Newsletter I mentioned that we have a problem with PayPal. That is ongoing.

David commented that financial position a lot more favourable than expected due to a total of approx. \$16k coming from 4WD show dividend and termination, although noted we will have a reasonable tax bill.

Some discussion from the floor (Bob A) wanting a better understanding of the long term viability of the club now we don't have show revenue. Committee to present long term view over the next few months but it was noted club is well resourced for the foreseeable future.

Treasurer also reported on issues relating to Paypal and problems getting funds released from them. Once received intention is to close this payment arrangement permanently.
